### **Confirmation of Financial Resources Form Instructions for the Chile Student Visa**

The Chilean Consulate requires your last Bank Statement, **and/or** your financial aid letter, **or** your parents' last Bank Statement **and** a notarized letter stating they (your parents) will be responsible for your permanency in Chile. This is referred to as the “**proof of financial status**” or “**proof of sufficient means of support.**”

In case you cannot provide a bank statement or a financial aid letter, have your parents complete the attached Confirmation of Financial Resources Form (this form must be notarized). On the Confirmation of Financial Resources form, be sure that your parent fills out the one that states he/she will be supporting you (the top box) and crosses out the one that does not apply to him/her (the bottom box).

Complete the gray boxed areas on the Confirmation of Financial Resources as appropriate indicating the amount of money you will be receiving from your parents. This amount should be **no less than \$500 per month**. Think about it – the more ways you can show the consulate that you have enough money to survive in Chile, the better.

**The Confirmation of Financial Resources must be notarized.  
Do not sign until in the presence of a Notary Public.**
